CHANGE TO DEPARTMENT STANDING RULES

SUBJECT OF RESOLUTION: DUES INCREASE

ARTICLE NUMBER III

SECTION NUMBER 7 (a)

WHEREAS, In the last eight years, The American Legion Department of Washington has suffered a dramatic decline in membership due a lack of membership renewals, reinstatements, and insignificant recruiting of new members resulting in an unhealthy drop in membership revenue; and

WHEREAS, A lack of revenue would cause the scaling back and/or elimination of many programs and services of The American Legion Department of Washington, and would prevent The Department's ability to meet its obligation to its employees as well as the community, state, and nation as articulated in the Preamble of The American Legion Constitution; and

WHEREAS, The Department membership in 2008 was 9881, and 2016 membership now stands at 6,010 - a difference of approximately 3,871 members resulting in a significant loss of revenue since 2008; and

WHEREAS, in 2013 there was an increase of Department annual dues for Senior members of Four Dollars (\$4) but this increase covered only the National Per Capita increase of Four Dollars (\$4) which took effect 2012-2013 fiscal year and there was no increase in our Department's net revenue; and

WHEREAS, The Department Senior Member per capita dues have remained constant at \$15.00 since 2008 despite the decreasing revenues and increasing expenses, now, therefore, be it

RESOLVED, By the American Legion Department of Washington in that the Senior Member annual per capita dues of The Department of Washington be increased by an amount no greater than Five Dollars (\$5) but no less than Two Dollars (\$2); and be it further

RESOLVED, That the amount of increase to be recommended by the Finance Committee at the Department of Washington 2017 Mid-Winter Conference, based on the Actual Income and Expenditures reported at that Conference, and the amount of increase be approved by the membership at that time.

FINALLY RESOLVED, That this Senior Member per capita dues increase will take effect on August 1, 2017.

Whereas: Department Standing Rule Article VI, Section 9 Girls State (j) was discussed at Feb. 2016 Committee Meeting

Whereas: Standing Rule states that to submit a tentative budget 5 days prior to Department Convention, which is not always possible because not all the bills will have been paid.

Whereas: By deleting the remainder of the Standing Rule detailing the responsibilities of Director is covered shall have full administrative authority and more of a procedure policy.

Now therefore be it resolved that: Department Standing Rules Section 9: Girls State (j) read: The Director shall have full administrative and financial authority over the functioned aspects of the program; she is to prepare and submit budget by Feb. 1 of the ensuing year to Department Finance Committee and Executive Committee.

And be it further resolved that: Standing Rule Article VI, Section 9 be re-lettered as necessary;

WHEREAS: The Evergreen Girls State committee met in Feb. 2016 to plan for 2016 Girls State Session

WHEREAS: The following was brought up about the rotation of the Girls State Committee members.

WHEREAS: To add consistency into the rotation of Committee members as it is sometimes difficult to find members to participate on the committee.

WHEREAS:: Our current Department Standing Rules, Article VI, Section 9-Girls State (a) states; This Girls State program shall be governed by the Girls State Committee.

NOW THEREFORE BE IT RESOLVED THAT: Our current Department Standing Rules, Section 9 Girls State currently reads (a) The Girls State program shall be governed by a Girls State Committee composed of: 1. The Department President 2. A rotating committee of five (5) members selected from the membership at large, one (1) or more to be appointed by Department President, for a term of three (3) years, plus a Director who is appointed by the Department President as stated in Article VI, Section 9 (c)

- (b) The director will oversee and coordinate the activities of the Girls State Committee. She must have served a minimum of one (1) year on the rotating committee. The five (5) rotating members may not be appointed for more than two (2) consecutive terms. There shall be no time limit to the length of office the Girls State Director, subject to the appointment of the Department President.
- (c) The Department President shall annually designate an individual from the membership at large as Director of Girls State for that year.
- (d) Vacancies in the committee shall be filled by the Department President with the approval of the Department Executive Committee.

Now Therefore be it resolved that: Department Standing Rules Article VI, Section 9-Girls State (a) reads: The Girls State program shall be governed by the Girls State Committee composed of 1. The Department President 2. A rotating committee of five (5) members plus a Director who is appointed by the Department President as stated in Standing Rule Article VI, Section 9 (c) The selection of the Girls State committee is from the membership at large, for a term of five (5) years. One (1) member rotating off the committee each year and now one appointed each year by Department President. After a committee member has served five (5) years on the committee she must stay off the Girls State Committee for one (1) year before being eligible for reappointment to the committee. The staff at Girls State will include the members of the Girls State Rotating Committee.

- (b) The Department President shall annually designate an individual from the membership at large as Director of Girls State for that year. The Director will oversee and coordinate the activities of the Girls State Committee. She must have served a minimum of one (1) year as on the Evergreen Girls State Committee rotation committee. There shall be no time limit to the length of office of the Girls State Director, subject to the appointment of the Department President.
- (c) Vacancies in the committee shall be filled by the Department with the approval of Department Executive Committee. If a vacancy occurs in the rotation committee the person appointed to fill the vacancy will finish out the vacant term on the Girls State Committee.

AND BE IT FURTHER RESOLVED THAT THE: Department Standing Rules Article VI, Section 9 Girls State be re-lettered as necessary , and become effective immediately following the close of Department Convention 216.
